Ordinance No. 5253

**AN ORDINANCE AUTHORIZING THE TRADE  
OF POLICE FIRING RANGE ACCESSORIES,  
NO LONGER NEEDED FOR MUNICIPAL  
PURPOSES TO PRO ARMAMENT;  
AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to Article II of its Charter, the City of Brecksville may exercise its power of local self-government through the enactments of the Council; and

WHEREAS, the Mayor and Council have determined that certain equipment is no longer being used or is no longer needed for a municipal purpose and have been offered store credit in the amount of one thousand dollars (\$1,000.00) trade in value from Pro Armament. The store credit can be used at the City's discretion on purchases such as spare parts and accessories for our current weapons.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:


**SECTION 1.** The Mayor be, and he hereby is, authorized to trade in the following equipment no longer needed for a municipal purpose to Pro Armament for store credit in the amount of \$1,000.00:


- 1) 12 - EOTech rifle optics
- 2) 3 - Simunition Colt 1911 conversion kits
- 3) 2 - Simunition Sig Sauer P225 conversion kits
- 4) 13 - Benelli M1 Super 90 forends
- 5) 1 - Surefire 617F-A Tactical Light for Benelli S90 Shotgun
- 6) 1 - Surefire 618 Tactical Light for Remington 870 Shotgun
- 7) 1 -- C.M.&T Company stock for Marlin 9mm & .45 Carbine

**SECTION 2.** The Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency relates to the need to dispose of the outdated equipment, therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise, from and after the earliest period allowed by law.


