Resolution No. 5129

A RESOLUTION AUTHORIZING THE MAYOR TO APPLY FOR A 2021 HEALTHY URBAN TREE CANOPY GRANT COORDINATED BY THE CUYAHOGA COUNTY DEPARTMENT OF SUSTAINABILITY, THE CUYAHOGA COUNTY PLANNING COMMISSION AND THE CUYAHOGA SOIL & WATER CONSERVATION DISTRICT, WITH ASSISTANCE FROM THE CUYAHOGA COUNTY BOARD OF HEALTH TO PROVIDE FUNDING FOR TREE PLANTING, PLANNING AND MAINTENANCE PROJECTS; AND DECLARING AN EMERGENCY

WHEREAS, the importance of a healthy tree canopy was emphasized in the 2019 Cuyahoga County Climate Change Action Plan and the 2019 Cuyahoga County Urban Tree Canopy Update; and

WHEREAS, this funding opportunity for tree planting in Cuyahoga County aims to lessen the impact of climate change to county residents and communities.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. The Mayor is hereby authorized on behalf of the City of Brecksville to prepare and execute an application for a 2021 Healthy Urban Tree Canopy Grant coordinated by the Cuyahoga County Department of Sustainability, the Cuyahoga County Planning Commission and the Cuyahoga Soil & Water Conservation District, with assistance from the Cuyahoga County Board of Health to provide funding for tree planting, planning and maintenance projects. If successful in obtaining a grant, the Mayor is authorized to execute whatever documents are necessary to effectuate the receipt of grant funds.


SECTION 2. The Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes expressed in Section 1 hereof, said amounts to be charged to the appropriately designated Fund.

SECTION 4. The Council declares this Resolution to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is to make a timely application, therefore, said Resolution shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise, from and after the earliest period allowed by law.
