Ordinance No. 5521

**AN ORDINANCE AUTHORIZING THE PURCHASE OF
A KUBOTA WORKSITE UTILITY VEHICLE FROM
AKRON TRACTOR & EQUIPMENT, INC. FOR THE
COMMUNITY CENTER THROUGH SOURCEWELL
(FORMERLY THE NATIONAL JOINT POWERS
ALLIANCE); AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to Article II of its Charter, the City of Brecksville may exercise its power of local self-government through the enactments of the Council; and

WHEREAS, the Director of Purchasing for the City of Brecksville has been authorized to register with SourceWell (formerly The National Joint Powers Alliance); and

WHEREAS, the City of Brecksville deems it cost effective and in the City's best interest to purchase equipment according to the pricing established under the SourceWell proposal.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. The Mayor be and is hereby authorized to enter into a contract on behalf of the City of Brecksville with Akron Tractor & Equipment, Inc.. through SourceWell (formerly The National Joint Powers Alliance) and specifically contract #122220, for a Kubota Worksite Utility Vehicle in the amount of twenty-three thousand, nine hundred thirty-three dollars and eighty-six cents (\$23,933.86), including a six thousand dollar (\$6,000.00) discount on the trade-in of a 2011 John Deere Gator, for the Community Center, as set forth in the proposal attached hereto as Exhibit "A".

SECTION 2. The Mayor be and is hereby authorized and directed to enter into a contract on behalf of the City of Brecksville with Akron Tractor & Equipment, Inc., as set forth in Section 1 hereof, said contract to be in such form as is approved by the Director of Law.

SECTION 3. The Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof, and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes as expressed in Section 1 hereof, said amounts to be charged to the appropriately designated Fund.

SECTION 4. The Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the Community Center's need for the equipment, therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
