**A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A
SWAG MOU ADDENDUM A3 TO AMEND THE MEMORANDUM OF
UNDERSTANDING FOR SHARED CRASH INVESTIGATION SERVICES
KNOWN AS THE SOUTH WEST ACCIDENT GROUP (SWAG); AND
DECLARING AN EMERGENCY**

WHEREAS, on December 11, 2018, the Police Departments of Parma, Parma Heights, Brooklyn, Brook Park, Seven Hills entered into a memorandum of Understanding pursuant to ORC 737.04 for shared crash investigation services known as the South West Accident Group (SWAG); and

WHEREAS, the Brecksville Police Department desires to become a member of SWAG.


NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:


SECTION 1. The Mayor be, and he hereby is, authorized to enter into a SWAG MOU Addendum A3 to amend the Memorandum of Understanding for shared crash investigation services known as the South West Accident Group (SWAG) to allow the Brecksville Police Department to become a member of SWAG.

SECTION 2. The Council declares this Resolution to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the need to amend the MOU for shared crash investigation services and become a member of SWAG, therefore, said Resolution shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise, from and after the earliest period allowed by law.

SWAG MOU ADDENDUM A3:

This addendum amends the Memorandum of Understanding for SHARED CRASH INVESTIGATION SERVICES known as the South West Accident Group (S.W.A.G.)

This document is in reference to a contract agreement (with final dating 12 /11/2018), between the police departments in the cities of Parma, Parma Heights, Brooklyn, Brook Park and Seven Hills. Also included are Addendums A, A2 to include the cities of Berea, Olmsted Township, Middleburg Heights and Broadview Heights. (addendums of various dates)

May it be known that the undersigned parties, for good consideration, do hereby agree to make the following changes and / or additions that are outlined below. These additions shall be made valid as if they are included in the original stated contract.

A representative of the original signing members will co-sign this addendum with binding authority as all represented parties agree to the changes. All member departments will be provided a completed copy of the updated MOU to include any addendums when completed.

The aforementioned cities agree to add the police department members to SWAG from the city of:

Brecksville, Ohio.

The signing representatives will be provided a copy of the original Memorandum of Understanding and any documentation included therein. This addendum will go into effect immediately upon signing by all parties and is revocable upon request of any involved unit representative.
