**COUNCIL OF THE CITY OF BRECKSVILLE**

Ordinance No. 5562

**AN ORDINANCE AUTHORIZING A CONTRACT  
WITH LINCOLN NATIONAL LIFE INSURANCE  
COMPANY FOR AN EMPLOYEE LIFE INSURANCE  
PROGRAM; AND DECLARING AN EMERGENCY**

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

**SECTION 1.** The Mayor be and is hereby authorized to enter into a contract with Lincoln National Life Insurance Company for an employee life insurance program as outlined in attached Exhibit "A" at a cost of twenty-five and seven tenth cents (\$0.257) per one thousand dollars (\$1,000) of coverage for a fifty-thousand dollar (\$50,000) term life policy per employee effective January 1, 2023 through December 31, 2023.


**SECTION 2.** The Mayor be and is hereby authorized to enter into a contract on behalf of the City of Brecksville with the said Lincoln National Life Insurance Company as set forth in Section 1 hereof, said contract to be in such form as is approved by the Director of Law.


**SECTION 3.** Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes expressed in Section 1 hereof, said amounts to be charged to the appropriately designated Fund.

**SECTION 4.** Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is that the same relates to the need to provide an employee life insurance program, therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
