Ordinance No. 5584

**AN ORDINANCE AUTHORIZING THE
PURCHASE OF FOUR (4) FORD POLICE
UTILITY SUV VEHICLES FOR THE POLICE
DEPARTMENT FROM MONTROSE FORD IN
ACCORDANCE WITH THE PROVISIONS OF
OHIO REVISED CODE SECTION 125.04(C); AND
DECLARING AN EMERGENCY**

WHEREAS, pursuant to the provisions contained in Section 125.04(C) of the Ohio Revised Code, the City of Brecksville has determined that it is cost effective to purchase equipment for use by the Police Department from Montrose Ford based upon equivalent State of Ohio, Department of Administrative Services – State Purchasing Contract terms, conditions, and specifications, but at a lower price.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. The Mayor be and is hereby authorized to enter into a contract on behalf of the City of Brecksville with Montrose Ford for the purchase of vehicles for the Police Department based upon the provisions of Ohio Revised Code Section 125.04(C), as follows:

Three (3) Ford Police Utility SUV Vehicles @ \$41,751.50 per vehicle	\$125,254.50
One (1) Ford Police Utility SUV K9 Vehicle <i>(Equivalent to OhioDAS State Contract #RS1010770's terms, conditions, and specifications, but at a lower price)</i>	<u>42,341.69</u>
TOTAL	<u>\$167,596.19</u>

SECTION 2. The Mayor be and is hereby authorized and directed to enter into a contract on behalf of the City of Brecksville with Montrose Ford as set forth in Section 1 hereof, said contract to be in such form as is approved by the Director of Law.

SECTION 3. Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof, and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes as expressed in Section 1 hereof, said amounts to be charged to the appropriately designated Fund.




