**A RESOLUTION AUTHORIZING THE PURCHASE
OF VARIOUS EQUIPMENT & RELATED
ACCESSORIES FOR THE CITY HALL AV
UPGRADES PROJECT THROUGH OMNIA
PARTNERS PURCHASING ORGANIZATION
AND NON-CONTRACT CABLES & PARTS FROM
AMAZON; AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to the provisions contained in Section 9.48 of the Ohio Revised Code, the City of Brecksville deems it cost effective to purchase certain services and equipment through OMNIA Partners Purchasing Organization.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. The Mayor be and is hereby authorized to enter into a contract on behalf of the City of Brecksville with OMNIA Partners Purchasing Organization, through its authorized vendor, B&H Foto and Electronics DBA B&H, said contract to be in such form as is approved by the Director of Law, for the purchase of equipment & related accessories for the City Hall AV Upgrades Project and non-contract related cables & parts through Amazon:





Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof, and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes

SECTION 3. The Council declares this Resolution to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the need to take advantage of the competitive costs obtained by OMNIA Partners, therefore, said Resolution shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise, from and after the earliest period allowed by law.
