**A RESOLUTION AUTHORIZING THE DIRECTOR OF  
HUMAN SERVICES TO SOLICIT SPONSORSHIPS FOR

BUSINESSES AND ORGANIZATIONS; AND DECLARING  
AN EMERGENCY**

**WHEREAS**, the Director of Human Services desires to offer senior-related businesses and organizations the opportunity to promote their services by sponsoring events and programs offered by the City of Brecksville; and

**WHEREAS**, sponsors will pay a sponsorship fee of one hundred fifty (\$150.00) and be provided a table in the foyer for a business display.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:


**SECTION 1.** The Director of Human Services be and is hereby authorized to solicit, on behalf of the City of Brecksville, sponsorships in the amount of one hundred fifty dollars (\$150.00) to sponsor certain events and programs, as set forth in the sponsor solicitation letter attached hereto as Exhibit "A".

**SECTION 2.** The Mayor is authorized to execute whatever documents and to take the necessary steps to effectuate the receipt of these sponsorship funds and the Director of Finance is hereby authorized to credit the proceeds of any sponsorship to the appropriately designated Fund.

**SECTION 2.** Council declares this Resolution to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the need to effectuate the receipt of the sponsorship funds, therefore said Resolution shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.


