**AN ORDINANCE ACCEPTING THE BID OF
SAFE STAFFING OF OHIO FOR TEMPORARY
GENERAL LABOR STAFFING AND RUBBISH/
RECYCLE/LEAF COLLECTION STAFFING FOR
THE SERVICE DEPARTMENT OF THE CITY
OF BRECKSVILLE FOR THE YEAR 2020;
AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to the publication of bids according to law, bids for the Temporary General Labor Staffing and Rubbish/Recycle/Leaf Collection Staffing for the Service Department of the City of Brecksville for the year 2020, in accordance with the specifications on file in the office of the Director of Purchasing, were received and opened according to law at 9:00 A.M. on Friday, November 15, 2019, and it being determined that the bid of Safe Staffing of Ohio was the lowest and best bid.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. The bid of Safe Staffing of Ohio for Temporary General Labor Staffing for the Service Department for the City of Brecksville for the year 2020 in an amount not to exceed ten dollars (\$10.00) for an hourly pay rate and thirteen dollars and ten cents (\$13.10) for an hourly bill rate and for Rubbish/Recycle/Leaf Collection Staffing in an amount not to exceed twelve dollars (\$12.00) for an hourly pay rate and fifteen dollars and seventy-two cents (\$15.72) for an hourly bill rate in accordance with the specifications on file in the office of the Director of Purchasing be, and the same hereby is, accepted.

SECTION 2. The Mayor be and is hereby authorized and directed to enter into a contract on behalf of the City of Brecksville with Safe Staffing of Ohio as set forth in Section 1 hereof, said contract to be in such form as is approved by the Director of Law.

SECTION 3. The Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes expressed in Section 1 hereof, said amounts to be charged to the appropriately designated Fund.

SECTION 4. The Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the Service Department's need for temporary manpower, therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise, from and after the earliest period allowed by law.


