Ordinance No. 5285

**AN ORDINANCE AMENDING SECTION  
145.13 OF THE ADMINISTRATIVE  
CODE AND THE EXEMPTED EMPLOYEES  
OF THE CITY OF BRECKSVILLE;  
AND DECLARING AN EMERGENCY**

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Brecksville,  
County of Cuyahoga, and State of Ohio, that:

**SECTION 1.** Section 145.13 of the Administrative Code be amended to read  
as follows:

“145.13 EXEMPTED EMPLOYEES.

The following job titles are hereby declared to be executive,  
administrative or professional positions and the persons employed  
therein shall not be entitled to overtime pay provided in Section  
145.08 or compensatory time off, although they shall be entitled to all  
other benefits accorded full-time employees of the municipality by  
this Chapter. In fixing the annual compensation for the positions  
listed herein, Council shall give due consideration to the  
responsibilities of each job and the duties and obligations such job  
imposes upon the employee.




**SECTION 2.** Section 145.13 of the Administrative Code as it existed prior to the effective date of this Ordinance and all other ordinances or resolutions inconsistent herewith be, and the same hereby are, repealed.

**SECTION 3.** The Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the need to add/remove certain positions from the list of exempted employees, therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise, from and after the earliest period allowed by law.


