50/50 FUNDING PROGRAM; AND DECLARING  
AN EMERGENCY**

WHEREAS, the Department of Public Works is soliciting for projects to be considered as part of the County Road 50/50 Program for funding years 2021 and 2022; and

WHEREAS, municipalities can apply for funding of up to fifty percent (50%) of the construction costs up to a maximum of two hundred fifty thousand dollars (\$250,000.00) per project.


NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:


**SECTION 1.** The Mayor be and hereby is authorized to complete the application process for funding through the Cuyahoga County Department of Public Works County Road 50/50 Funding Program. The Mayor is further authorized to execute whatever documents are necessary to complete the application process pursuant to the Program Policies attached hereto as Exhibit "A." If successful in obtaining funding, the Mayor is authorized to execute whatever documents are necessary to effectuate the receipt of funds.

**SECTION 2.** The Council declares this Resolution to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the need to complete the application process, therefore, said Resolution shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise, from and after the earliest period allowed by law.



Dear Mayor Hruby:

The Department of Public Works is soliciting for projects to be considered as part of our County Road 50/50 Program for the funding years of 2021 and 2022. Although funding is limited, the County strives to assist our local municipalities by providing this opportunity to fund a portion of your future project through this 50/50 funding program. The project shall be municipally administered; however, the County will require a review of the final plans prior to advertisement.

The County Road 50/50 Program Funding is awarded based on the number of users (ADT), pavement condition rating (PCR), age of infrastructure, economic health of the municipality, and previous awards from this funding program. Municipalities can apply for funding of up to 50% of the construction costs up to a maximum of \$250,000 per project. Although applications for multiple projects can be submitted by the municipality, only one project per municipality can be awarded each funding year.
