WHEREAS, the City also desires to purchase certain other related options not part of the State Contract.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. The Mayor be and is hereby authorized to enter into a contract on behalf of the City of Brecksville with the State of Ohio, Department of Administrative Services – State Purchasing, through its authorized vendor, Pfund Superior Sales Co., Inc., for the purchase of a Freightliner M2 Life Line Type I Ambulance with options and non-state related options for use by the Fire Department:
