Ordinance No. 5326

**AN ORDINANCE AUTHORIZING THE PURCHASE  
OF PATIO FURNITURE FOR THE AQUATIC CENTER  
FROM MIDSTATES RECREATION THROUGH  
SOURCEWELL (FORMERLY THE NATIONAL JOINT  
POWERS ALLIANCE) AND FOR THE PURCHASE OF  
OTHER NON-SOURCEWELL CONTRACT RELATED PATIO  
FURNITURE FROM VARIOUS VENDORS;  
AND DECLARING AN EMERGENCY**

**WHEREAS**, the Director of Purchasing for the City of Brecksville has been authorized to register with SourceWell (formerly The National Joint Powers Alliance); and

**WHEREAS**, the City of Brecksville deems it cost effective and in the City's best interest to purchase equipment according to the pricing established under the SourceWell contract; and

**WHEREAS**, the City also desires to purchase other equipment that is not part of the SourceWell Contract.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

**SECTION 1.** The Mayor be and is hereby authorized to enter into a contract on behalf of the City of Brecksville with MidStates Recreation through SourceWell (formerly The National Joint Powers Alliance) for the purchase of patio furniture for the Aquatic Center as follows:

*SourceWell Contract:*

Patio Furniture	\$24,216.00
Less 6% SourceWell Discount	<u>(1,378.26)</u>

**SECTION 2.** The Mayor be and is hereby authorized to enter into contracts on behalf of the City of Brecksville for the purchase of Non-Sourcewell contract related patio furniture for the Aquatic Center from various vendors as follows:

**SECTION 3.** The Mayor be and is hereby authorized and directed to enter into contracts on behalf of the City of Brecksville with MidStates Recreation, Patio Shoppers, Polywood and Admiral Outdoor Furniture as set forth in Sections 1 and 2 hereof, said contracts to be in such form as is approved by the Director of Law.



**SECTION 4.** Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 and Section 2 hereof, and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 and Section 2 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes as expressed in Section 1 and Section 2 hereof, said amounts to be charged to the appropriately designated Fund.

**SECTION 5.** Council declares this Ordinance to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the need for furniture for the Aquatic Center, therefore, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.


