**A RESOLUTION AUTHORIZING THE MAYOR
TO COMPLETE THE GRANT PROCESS FOR A
CORONAVIRUS EMERGENCY SUPPLEMENTAL
FUNDING GRANT THROUGH THE OFFICE OF
CRIMINAL JUSTICE SERVICES; AND
DECLARING AN EMERGENCY**

WHEREAS, the Ohio Office of Criminal Justice Services (OCJS) is a division of the Ohio Department of Public Safety and is the lead justice planning and assistance office for the state, administering millions of dollars in state and federal criminal justice funding every year; and

WHEREAS, OCJS evaluates programs and develops technology, training, and products for criminal justice professionals and communities; and

WHEREAS, the Bureau of Justice Assistance designated OCJS as the state administering agency for the Coronavirus Emergency Supplemental Funding program; and

WHEREAS, the Coronavirus Emergency Supplemental Funding Grant would be used for the purchase of a MoonBeam 3 UV-C machine that eliminates pathogens from intricate, hard to clean surfaces in as little as 90 seconds using high-intensity UVC light. It is ideal for healthcare disinfection of entire patient bed areas (i.e. bed rails, controls, call boxes, phones, tables), operating rooms, bathrooms and fixtures, toilet seats & grab bars, sinks, keyboards, monitors and work stations on wheels (WOWs). It has also been effective for squad cars, ambulances and other services vehicles. Included in the grant application is funding for PPE for our protective services.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. The Mayor be and hereby is authorized to complete the grant process for a Coronavirus Emergency Supplemental Funding Grant for the purchase of a MoonBeam 3 UV-C machine in the amount of sixty-five thousand dollars ((\$65,000.00). The Mayor is further authorized to execute whatever documents are necessary to complete the application process. If successful in obtaining a grant, the Mayor is authorized to execute whatever documents are necessary to effectuate the receipt of grant funds.

SECTION 2. Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof, and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the City. The Director of Finance be and is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 1 hereof, and is further directed to issue vouchers of this City in the amounts and for the purposes as expressed in Section 1 hereof, said amounts to be charged to the appropriately designated Fund.




