Resolution No. 5060

**A RESOLUTION AFFIRMING ALL FUNDS FROM THE
COUNTY CORONAVIRUS RELIEF DISTRIBUTION
FUND BE EXPENDED ONLY TO COVER COSTS OF
THE CITY CONSISTENT WITH THE REQUIREMENTS
OF SECTION 5001 OF THE CARES ACT, CREATING
THE LOCAL CORONAVIRUS RELIEF FUND 211,
AND INCREASING ESTIMATED RESOURCES AND
APPROPRIATION IN FUND 211; AND DECLARING
AN EMERGENCY**

WHEREAS, the Coronavirus Aid, Relief, and Economic Security Act, 116 Public Law 136, (the CARES Act) was signed into law by the President of the United States on March 27, 2020; and

WHEREAS, the Ohio General Assembly established a process for distributing funds provided by the "Coronavirus Aid, Relief, and Economic Security Act" in Senate Bill 310, now H.B. 481 of the 133rd General Assembly (S.B. 310); and

WHEREAS, S.B. 310, now H.B. 481 requires subdivisions receiving funds under Section 1 of the act, to pass a resolution affirming that funds from the County Coronavirus Relief Distribution Fund may be expended only to cover costs of the city consistent with the requirements of section 5001 of the CARES Act as described in 42 U.S.C. 601(d), and any applicable regulations before receiving said funds; and

WHEREAS, the city is requesting its share of funds from the County Coronavirus Relief Distribution Fund.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. All funds received from the County Coronavirus Relief Distribution Fund pursuant to S.B. 310, now H.B. 481 be expended only to cover costs of the city consistent with the requirements of section 5001 of the CARES Act as described in 42 U.S.C. 601(d), and any applicable regulations and guidance only to cover expenses that:

- (1) Are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19);
- (2) Were not accounted for in the city's most recently approved budget as of March 27, 2020; and
- (3) Were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020.

SECTION 2. In compliance with S.B. 310, now H.B. 481 the Director of Finance shall take all necessary action to:

- (1) On or before October 15, 2020, pay any unencumbered balance of money in the city's local coronavirus relief fund to the County Treasurer;
- (2) On or before December 28, 2020, pay the balance of any money in the city's local coronavirus relief fund to the state treasury in the manner prescribed by the Director of the Ohio Office of Budget and Management; and

(3) Provide any information related to any payments received under S.B. 310, now H.B. 481 to the Director of the Ohio Office of Budget and Management as requested.

SECTION 3. The Director of Finance be authorized and directed to establish the Coronavirus Relief Fund 211 for the accounting of funds from the County Coronavirus Relief Distribution Fund.

SECTION 4. The Director of Finance be authorized to increase estimated resources and appropriation in Fund 211, Local Coronavirus Relief Fund, as follows:

R211150-0819	Misc Grant – Federal	\$129,983.43
211150-2201	Misc Operating Supplies	\$129,983.43

SECTION 5. The Council declares this Resolution to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare, the reason for the emergency is the need to affirm that funds from the County Coronavirus Relief Distribution Fund are expended only to cover costs of the city consistent with the requirements of section 5001 of the CARES Act, create Fund 211 and increase estimated resources and appropriation in Fund 211, therefore, said Resolution shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise, from and after the earliest period allowed by law.
