**AN ORDINANCE TO AMEND ORDINANCE NO. 5277,
MAKING APPROPRIATIONS FOR CURRENT
EXPENSES OF THE CITY OF BRECKSVILLE
DURING THE FISCAL YEAR ENDING
DECEMBER 31, 2020, MAKING NECESSARY
APPROPRIATION AND REVENUE ADJUSTMENTS;
AND DECLARING AN EMERGENCY**

WHEREAS, the appropriations heretofore set to certain accounts of the City of Brecksville are insufficient to pay expenses incurred during the fiscal year ending December 31, 2020.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

SECTION 1. Ordinance No. 5277 passed December 17, 2019 making appropriations for expenses for the year 2020 is hereby amended as indicated herein below.

SECTION 2. That the Director of Finance be authorized to increase and decrease estimated resources and appropriations in the General Fund:
