**A RESOLUTION REQUESTING THE COUNTY  
FISCAL OFFICER ADVANCE THE SUMS ALLOWED  
BY LAW FROM THE PROCEEDS OF TAX  
LEVIES IN THE ACCOUNT OF THE CITY OF  
BRECKSVILLE, PURSUANT TO SECTION 321.34  
OF THE OHIO REVISED CODE;  
AND DECLARING AN EMERGENCY**

WHEREAS, Section 321.34 of the Ohio Revised Code provides that any and all tax revenue and the payment of special assessments held in the County Treasury to the account of the City of Brecksville, and lawfully applicable to the purposes of the current fiscal year may be drawn upon by request.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Brecksville, County of Cuyahoga, and State of Ohio, that:

**SECTION 1.** Pursuant to Section 321.34 of the Ohio Revised Code, the Fiscal Officer of Cuyahoga County be and is hereby requested to draw warrants in the maximum sum allowed by law, and the Treasurer of Cuyahoga County be and is hereby requested to pay to the City of Brecksville any and all tax revenue and payments of special assessments in the County Treasury to the account of the City of Brecksville and lawfully applicable to the purposes of the fiscal year 2020, including, but not limited to the following Special Assessment Accounts:

M911715	Paving and Sewer




